

**MINUTES**  
**SELECTPEOPLE'S MEETING**  
**LIMESTONE MUNICIPAL BUILDING**  
**WEDNESDAY November 18, 2020.**

**SELECTPEOPLE PRESENT:** Chairman, Jesse Philbrick Vice Chairman, Fred Pelletier, Paul Durepo, II, James Pelkey, Jr., and Irma Labreck

**I. Call Meeting to Order:**

The meeting was called to order by Chairman Philbrick at 6:30 p.m.

**II. Pledge of Allegiance and Prayer:**

The Pledge of Allegiance was recited by Chairman Philbrick, and he led the group in prayer.

**III. Adjustment to the Agenda:**

**A.** Selectperson Durepo, II states that according to the by-laws dated 2013 that after a municipal election new officers are to be elected.

Kelly Johndro informed the board that when Walt and Tadd were here that the by-laws were changed to only be voted after the town meeting. After discussion the board states that they made a motion but did not sign new by-laws. Ms. Johndro stated the new by-laws were on her old computer and they did not pass to the new one. Selectperson Pelletier states that he did sign the new by laws. Finch states that the file system is not up to date and we do not have no sign copies.

Selectperson Durepo, II asks to open the floor to vote on new officers. Selectperson Labreck feels that we should also elect new officers.

Selectperson Durepo, II made a motion to follow the by-laws of 2013 to elect a new chair and vice chair tonight, seconded by Selectperson Labreck. **Motion Passes 5 to 0.**

Selectperson Durepo, II opens the floor by nominating James Pelkey, Jr as Chairman; seconded by Selectperson Pelkey, Jr.

Selectperson Pelletier nominates Selectperson Philbrick for the chairman position; seconded by Selectperson Philbrick.

Selectperson Pelkey, Jr ceases nominations; seconded by Selectperson Durepo, II. **Motion Passes 5 to 0**

Selectperson Philbrick asked all those in favor of Selectperson Pelkey. **3 in favor** when asked who was in favor of Selectperson Philbrick **the vote was 2 in favor.**

Selectperson Philbrick states its your deal now boys you got your way Durepo, I wont waist my time here anymore. He also states you can put another ad in the paper for another selectperson. As he passes the Town Manager, he states you will have my paper in the morning, and as your evaluation goes with me it is not good. Philbrick states what they did was wrong.

Selectperson Labreck made motion to keep Selectperson Pelletier on as Vice Chair; seconded by Selectperson Durepo, II. Selectperson Pelkey, Jr ceases nominations; seconded by Selectperson Durepo, II. **Motion Passes 4 in favor**

**B. Brandon Saucier – Assessor:**

Selectperson Pelletier thanks Brandon for being at the meeting and wants to know what he is looking for vs. what the board wants. Brandon states he understands that he will be doing the assessing and the personal property also. It will be sixty dollars and hour and he if he does personal property, he also wants to do the MVR. He wants to do it all or just the real estate. Saucier states it will take 3 to 5 years to straighten things out. In that time if the town was to do a re- evaluation, we would be able to.

Assessing would be contractual and code is something different. Saucier states he will meet with Finch to see what the town needs and what they can afford.




